ORDER APPROVING AN AMENDMENT TO A LEGAL SERVICE AGREEMENT WITH THE LAW FIRM OF BERCHEM, MOSES, AND DEVLIN INCREASING THE MAXIMUM COMPENSATION FROM \$99,000 TO \$198,000 FROM FY 2024-2025 LINE ITEM 11331010-56696.

WHEREAS, on July 1, 2024, the City of New Haven, Connecticut (the "City") and the law firm of Berchem, Moses, and Devlin (the "Contractor") entered into a legal service agreement (2024-CON-0288) to assist the City of New Haven with its legal services in support of the Office of Labor Relations in the amount of Ninety-Nine Thousand Dollars and Zero Cents (\$99,000.00); and,

WHEREAS, the City has been and continues to be satisfied with all of the services rendered to by the Contractor under the Agreement; and,

WHEREAS, the City and the Contractor desire to amend the legal service agreement to increase the compensation by an additional Ninety-Nine Thousand Dollars and Zero Cents (\$99,000.00); and,

WHEREAS, funds are available from Account Numbers 11331010-56696.

NOW THEREFORE, BE IT ORDERED, by the New Haven Board of Alders, that the maximum compensation to the existing legal service agreement with the law firm of Berchem, Moses, and Devlin be increased from \$99,000 to a total of \$198,000.
