ORDINANCE AMENDMENT TO APPROPRIATING ORDINANCE #1 RECLASSIFYING POSITIONS WITHIN THE LABOR RELATIONS DIVISION; LABOR STAFF ATTORNEY POSITIONS #8006 AND #25001 TO SENIOR LABOR RELATIONS COUNSEL AND LABOR RELATIONS ASSOCIATE, RESPECTIVELY.

WHEREAS, Section 2-386 of the Code of General Ordinances requires the approval of the Board of Alders to create a position not included in the budget as adopted, or to reclassify an existing and included position; and

WHEREAS, the Labor Relations Division requires updates to position titles and classifications to better reflect responsibilities and operational needs; and

WHEREAS, the Labor Relations Division is seeking approval to reclassify the following position, to reflect increased responsibilities and expertise required for the role; and
